YOU, for yourself, your personal representatives, heirs, and next of kin, acknowledge, agree and represent that you have, or will immediately upon entering the Facility and any restricted areas, and will continuously thereafter, inspect such areas and all portions thereof which you enter and with which you come in contact, and you do further warrant that your entry and your participation, if any, in any event at the Facility constitutes an acknowledgment that you have inspected such areas and that you find and accept the same as being safe and reasonably suited for the purposes of your use, and your further agree and warrant that if, at any time, you are in or about such areas and you feel anything to be unsafe you will refuse to participate further in an event, will immediately advise the officials of such unsafe situation and will leave the areas and not return.
